Recognition

I have worked on a number of cases of note, including for the manufacturer and supplier of medical devices in a class action regarding the design of a medical device, for shareholders on the class action brought against AWB concerning contracts with Iraq during the UN Oil for Food Program, for Optus in a claim brought by the ACCC for misleading or deceptive advertising, and for Optus for injunctive relief against Vodafone. I have appeared both as sole counsel and led by a number of senior counsels. I have appeared in all levels of courts as well as tribunals, including the Federal and High Court of Australia, the Local, District and Supreme Courts of NSW, the Family Court of Australia, NCAT and Fair Work Australia.

The matter involved interlocutory disputes including an application for security for costs. The matter settled prior to hearing.
