

Biographical

Before coming to the law, Mr Gibson taught in the United Kingdom, Bangladesh and the Sultanate of Oman. He is an Oxford Blue in hockey, played for British Universities and England Schools. He also represented the Sultanate of Oman at the Hong Kong 7s in rugby

Mr Gibson commenced practice as a lawyer with Allen Allen & Hemsley (now Allens<Linklaters) as a solicitor in 1987 before becoming a Senior Associate. He subsequently was a partner and the National Head of Dispute Resolution at Andersen Legal and Special Counsel at Corrs, prior to coming to the bar in 2005.

As a solicitor Mr Gibson acted in a number of high-profile inquiries from the early 1990s, including the Martin Banking Inquiry, the Special Commission of Inquiry into the Allegations made by Mrs Franca Arena; the Royal Commission into the collapse of HIH; the Special Commission of Inquiry into the Waterfall Rail Accident and the Special Commission of Inquiry into the Medical Research and Compensation Foundation (the James Hardie Inquiry).
